- having regard to Italian Presidential Decree no. 162, dated 10 March 1982, and in particular articles 1 (comma 2, letter c), 16 and 17 regarding advanced courses;
- having regard to article 6 of Law no. 341 dated 19 November 1990;
- having regard to Italian Ministerial Decree no. 270 dated 22 October 2004 approving new Regulations on the educational autonomy of universities and supplanting Ministerial Decree no. 509 dated 3 November 1999;
- having regard to the Charter of the University of Milan, issued by Rectoral Decree on 15 March 2012;
- having regard to Milan University Regulations, issued by Rectoral Decree on 12 June 2008, and in particular the article regarding rules governing advanced courses;
- having regard to the decisions of the Academic Senate, in the session of 11 July 2017 and 16 January 2018, and of the Board of Directors in the session of 18 July 2017 and of 30 January 2018, through which said academic bodies approved the activation of advanced courses for academic year 2017/2018

HEREBY DECREES

All those holding the academic qualifications indicated for the advanced course, or equivalent qualifications, even from foreign universities, may apply for admission.

Attendance on the various advanced course activities is mandatory.

Application for admission

Applications may be submitted from **11 May 2018 to 2pm 12 June 2018** as follows:

- 1) register as an external graduate through the University portal at <https://www.unimi.it/registrazione/registra.keb>. You can skip this step if you are already registered on the portal or hold University credentials (e.g. students or graduates from the University of Milan);
- 2) use your credentials to access the portal at SIFA online services (<http://www.unimi.it/apps/hpsifaprivata.xsl>);
- 3) submit your application for the course by accessing *Servizi online SIFA* (SIFA online services) > *Servizi di ammissione* (Admission services) > *Corsi di perfezionamento* (Advanced Courses) ([link](#)).

Candidates must also present the following documentation to the course secretariat (indicated in the attached course profile) **by the 2pm, 12 June 2018 deadline**, under penalty of exclusion from the selection procedure:

- a) copy of the receipt obtained at the end of the online application procedure;
- b) a detailed cv (specifying the academic degree held) for use in the selection process and in assigning any scholarship;
- c) any other document requested in the individual course profile.

Those holding a non-university academic qualification issued in Italy that is by law equivalent to a degree must also submit a copy of the academic qualification and copy of their secondary

school diploma to the Postgraduate and Continuing Training Office (*Ufficio Formazione Permanente e Continua*).

Besides submitting the above, those holding a foreign academic qualification must present the following documents (original or authenticated copies) to the Postgraduate and Continuing Training Office (*Ufficio Formazione Permanente e Continua*) so that the office may assess whether the qualification grants admission to the advanced course: the **academic qualification** and **its official translation authenticated** pursuant to current legislation in the country in which it was awarded, and a **Statement of Validity** (*Dichiarazione di Valore in Loco*) issued by the Italian diplomatic office (Embassy or Consulate) in the country in which the qualification was awarded. Candidates who completed the qualification in an EU State may submit, in place of the translation and Statement of Validity, a Diploma Supplement, authenticated pursuant to current legislation. In place of the Statement of Validity and the Diploma Supplement, candidates who were awarded the qualification abroad can submit a statement of validity issued by ENIC-NARIC Centres or by the Diplomatic Office in Italy.

Rankings

The ranking of successful candidates will be published on the University website through *Servizi online SIFA* (SIFA Online Services) (http://www.unimi.it/hpsifa/nonProfiledPage_100.html). To view the ranking select *Graduatorie Ammissioni Corsi post laurea* (Postgraduate Course Ranking) > *Graduatorie Corsi di Perfezionamento* (Advanced Course Ranking). Publication of the ranking list serves as official notification, and no personal communication will therefore be sent out to candidates.

Enrolment

Those admitted to the course must enrol, under penalty of forfeiture, **within 5 working days** of the publication of the ranking, using the *Servizi online SIFA* (SIFA Online Services) > *Servizi di immatricolazioni ed iscrizione* (Matriculation and enrolment services) > *Immatricolazioni*

(Matriculation) > *Immatricolazione ai Corsi di perfezionamento* (Matriculation on Advanced Courses). Students must at this point also pay the enrolment fee indicated in the course profile; payment must be made by credit card. Those with an address in Italy may make the payment using the MAV (notice of payment) form generated at the end of the on-line enrolment procedure.

Enrolment is completed automatically once the candidate has completed all steps required.

Late payment of the enrolment fee will be subject to a € 30.00 late payment charge.

If the enrolment fee is paid by persons other than the student or by an Institution, Agency or Company, these must make the payment in the same way and respecting the deadlines indicated above, under penalty of forfeiture. As the advanced course is part of the University's institutional activities, no VAT is applied to the enrolment fee and candidates will not receive an invoice.

At the time of enrolment foreign candidates must deliver a copy of their Italian tax code number (*codice fiscale*) to the Postgraduate and Continuing Training Office (*Ufficio Formazione permanente e continua*). Candidates from outside the EU must also show their permit of stay (original copy). Withdrawal

Requests to withdraw from the advanced course must be made in writing. Students are entitled to reimbursement of any payments made if the request is made prior to the actual start of the course; 10% of the enrolment fee, and in any case no less than € 51.65, will be withheld by the University to cover general and administrative costs.

Students cannot interrupt their advanced course studies at any time or for any reason.

Advanced Course in “Methods and measurements for assessing rehabilitation outcomes in neurodevelopmental disorders”

Coordinator: Prof. Antonella Delle Fave

Learning objectives

The course, organized in collaboration with the association “La Nostra Famiglia”, aims to provide participants with methodological and technical instruments for assessing the outcome of rehabilitation treatments in complex situations such as those present in neurodevelopmental disorders. The acquired competencies include the ability to formulate treatment objectives in collaboration with the patient and/or caregiver, to measure progress and identify and measure outcome indicators. The course includes practicals (simulation of clinical cases) on the use of the goal attainment scale (GAS), a particularly useful tool for measuring the outcome of rehabilitation.

Number of Places available

A maximum of 20 places are available. The University reserves the right to not activate the course should less than 15 students enrol on the course.

Admission requirements

The course is tailored for those holding a bachelor's or master's degree in one of the following classes under Ministerial Decree 270/2004:

- L/SNT2 - Rehabilitation Professions;
- LM/SNT2- Health professions of rehabilitation sciences.

Selection procedure

Candidates will be selected through interview and assessment of their CV.
